Finance Chair 2020 Annual Report:

Audit of financial documents for AIS Rochester was completed on March 18, 2021, final budget report is posted on website located in information, Treasurer. At end of 2020 we had \$4,521.81 in checking account and \$16,043.65 in savings account total of \$20,565.46. Current 2021 AIS budget approved is \$21,400.00.

April Report:

Reminder to all chairpersons next year's budget requests must be submitted to Finance Chair by August 1st to be considered for next year's budget. Thanks again to all (groups and individual members) that continue to send their Tradition 7 donations to AIS Rochester - without your support we would not be able to continue our mission.

Discussion-we are behind in donations compared with last year. In our next newsletter please tell your groups to consider making a donation to AIS.

Activities: Debbie-Eddie has met with St. Anne's about the Tureen Supper. Contact is Carol. Possible weekend after Labor Day. More to come with the possibility of outdoor activity. Nancy M. is willing to help if needed. Debbie to follow-up with Ed.

Intergroup Rep: Open position.

Unfinished Business: By-Law's update-see Vice Chair report, AWSC meeting in March sees NY North website for minutes of reports for the March meeting. Spring Assembly in May, see AIS and NY North website.

New Business: Will AIS consider zoom corporate account for groups to use? If AIS would purchase. Groups who cannot afford their own account could pay some fee to AIS, this may help with groups staying open and would help with self-support. What does the group think?

Discussion: What do groups do now?

- Members use personal accounts, the options most cost approximately \$140 a year. This works as long as meetings using one account do not occur at the same time.
- Some districts share cost of accounts. District 19 used this option, and each group sends contribution.
- Some groups use free zoom app, this limits meetings to 40 minutes, then log out and log back in.
- Some "sister" meetings share account expense, working with group treasurers.

Self-supporting would AIS buying subscription honor this tradition? Members noted that smaller, distant meetings have problems connecting with other meetings. AIS account could be a means of AIS serving and growing our meetings during decreasing face-to-face meetings. Janise notes that there is a membership for non-profits for zoom available, she will send information.

Mel if we do this who would administer, and service positions-will new ones be needed? Group agrees to investigate options and confirms desire to support smaller meetings with information and tech help in some form. Will discuss at next meeting.

Jacqui- DR support district 2, no DR as of now, how can we support this district? Any ideas? Jacqui not present, will forward some DR contacts. - Loron to do.

- Outreach about Al-Anon continues. In person presentations at court mandated programs for DWI/DUI. Occur every 6 weeks. Churches have been contacted to add information about Al-Anon meetings they host to add to bulletins or newsletters. Literature is being delivered to recovery programs in our area.
