Electronic Meeting Chair and Calendar- Ellen V. thank you for teaching Zoom to our new attendees to the AWSC (Area World Service Committee) today. Thank you for encouraging group discussion about important topics

**Book Depot**: **Rebecca** - Group discussion includes these points about ordering and receiving books. We agree having literature available easily is a goal of AIS.

- Books ordered from AIS depot down. Individuals are requesting, but groups not.
  We are not buying books so budget neutral.
- Newcomer packets 99 sent out since March!
- Following cleanliness and no touch dropoff of books-Thanks Rebecca.
- Several members willing to deliver books also to avoid shipping costs
- Can we order books with a shopping cart from AIS website-see discussion

### **Discussion-book ordering options**

- Presently we have email and ship order form from AIS Rochester website, people can also leave phone messages with follow up.
- Presently we cannot accept credit card payment for books. Group wishes we could.
- Building Shopping Cart option into our website is time consuming and can create more expense for AIS. Discussed, if this would increase CAL being enjoyed by more people, should we pursue? We would like folks to have options besides amazon.
- WSO has online ordering/shopping cart and credit cards online NOW-
- **ACTION**-Website- put link to WSO for literature in front page, AND add to the line "did you know" " you can purchase Al-Anon literature at office AND literature form below"-to direct the eye to the information.
- ACTION- Mel will look into cost of shopping cart options for book ordering.
