- Attended recovery fair at Park Ridge, very positive experience. Alanon was asked to start a
 meeting at ROCovery Fitness (Dewey near Driving Park), Wednesday evenings requested.
 Discussion about whether Wednesday is the best night, given that there are two other Alanon
 meetings on Wednesday night. Concern that city/west side is underrepresented. Loren will ask
 ROCovery if there are other nights available.
- Sent around list of meetings to determine which meetings aren't represented at the AIS meeting, Loren will try to get to those meetings in the next month.

Alateen – see report.

One Alateen (AMIAS) resigned, leaving one remaining (Diane). Another individual came forward
who is also AMIAS trained; she is traveling now and not available. Currently meeting is on-andoff depending on whether there are two AMIAS available; sometimes older teens will join the
Alanon or open AA meeting at the same location/time. Loron to speak to Diane about what can
be done to attract more people to AMIAS training. There is a flyer available to take to
community groups/schools for Alateen outreach.

Book depot –

- Only half-dozen Intimacy books of the 5th case ordered. WSO is currently out of stock; will order as soon as they're back in stock.
- Need to reprint the beginner meeting notices in the newcomer packet, but has confusion about where the Pittsford Monday meeting is held. Was at St. Paul's, moved to community center, moved back to St. Paul's church due to storage issue.
- 2018 World Service Conference Summary currently purchased by book depot for \$5.00, but
 can also be found online. Question regarding whether it's worth it to purchase the notes;
 feedback from group is that some people like to have a copy, to see the full discussion of topics
 with history.
- Membership survey would like to include link to 2018 survey results in newsletter.
- The literature catalog will soon be available on the AIS website (thanks, Mel!). Connie to put a "stay tuned" notice on the website.
- Book sales are up from last year at this time, thanks in part to Rebecca's hard work!

Public outreach -

- Speaker's bureau there is a WSO pamphlet (guideline) regarding speaking in public; there really aren't any hard requirements to be a speaker. Kathleen is looking to schedule something in the next month to discuss the WSO guidelines with any interested speakers. Connie will put something in the newsletter.
