Meeting conduct:

Some members reported that there is dominance at our meeting: suggestion was to continue the practice of reading guidelines at meetings to avoid double dipping.

Our purpose as a District:

- 3. Support GR's in general ie: service questions, group concerns
- 4. District to establish long term goals and short-term goals

We discussed District 29's response to the NYN thought force on electronic meetings service positions. The district has concerns regarding people participating from other states, but would consider. Laura, our DR, sent the survey results from our district discussions to NYN.

 new GR meeting at Assembly.
