Newsletter: May 2017 Newsletter Report

Regarding the Rochester AIS Newsletter, feedback is always welcomed and I appreciate the help in streamlining this task. Because of your feedback and suggestions I will implement the following newsletter changes:

In May's Newsletter, I will be noting changes regarding event/anniversary flyers and registration forms. They will no longer be included in the newsletter. I will direct readers to access event/anniversary flyers/ registration forms by going to the aisrochester.org website & use the "Activities" drop down feature.

The rationale for this change is three-fold:

- 1. In order to send a large document, I am required to optimize (shrink) the newsletter. As a result, the resolution of document images (pdf flyers/registrations) is sometimes compromised. I am not willing to re-send original registration forms as some have requested but will suggest that these flyers can be accessed through the AIS website or original "organization" destination. This will be noted in the newsletter as stated above.
- 2. Feedback has indicated that the newsletter uses a substantial amount of printer ink, which is inconvenient and costly.
- 3. It has been observed that people in the meetings do not generally take the time to read the newsletter from the clipboard, so being able to access it electronically is more convenient.

When I send out the newsletter, I will **not** include the following directive in the distribution email:

GRs/ISRs/DRs: Please copy and post to your group's clipboard.

Instead, the directive will read:

There is a legitimate concern about the amount of ink required to print the newsletter; printing and posting it to your group's clipboard is optional.

Please make an announcement to your group that the Newsletter can be seen and subscribed to by going to the aisrochester.org website, (use "Information" drop down feature/click on newsletter).

Hopefully, use of our Rochester AIS Website will increase.
