# **Spring Assembly Highlights:**

- Delegates report (Kathi D), had just been to WSC (World Service Conference) for 5 days. Is our work aligning with theirs?
- Reimbursement of travel expense was voted on. Need to turn in gas receipt or mapquest travel information
- CAL is copyrighted. If we photocopy it we cannot use it outside of the meeting. If we photocopy information and pass it out at a meeting, we must collect it at the end of the meeting. The exception is the Al-Anon Guidelines, available as downloads, item # G-15 and others.
- ODAT- CAL ebook is not available. The version that is out is a pirated version
- 7<sup>th</sup> Tradition Myth- donating closer to home is the preferred step in what to do with an Ample Reserve. It costs the WSO \$ 325.21 per year to support each group
- Correct language is "Ample Reserve" not "Prudent Reserve"
- Does NYN know how much it costs the Area to support each group?

- This is an Election Assembly. Area level Officers and Coordinators are on a 3 year rotation. This term is completed at the end of 2023.
